**Manager's Corner**

As we start off another new year, I want to take just a minute to thank the members of the Board of Directors for their hard work throughout this last year. Under the direction of Joel Rosenthal as the President, Doris Davidoff, Janice Davidson, Harvey Galan, Mort Goldstein Sy Kugelmas and Saul Siegel have all taken a personal interest in their chosen duties. Residents, vendors and guests constantly tell me Majestic Isles has never looked better.

I'd also like to take time to remind residents of a few of the Board's accomplishments of 2010: Installing the video cameras in the guardhouse showed an almost immediate positive result. Review of our video recordings was instrumental in helping break up a burglary ring that was operating in Monroe, Miami-Dade, Broward, Palm Beach, and Martin Counties. We were able to provide the Sheriff's Office with a clear picture of the vehicle, license plate number and driver, and this made it possible for Sheriff's deputies to quickly apprehend the culprits who had broken into two homes in Majestic Isles as well as into many other residences in the five-county area.

M&P installed lawn drains on Lake 2, similar to the drains previously put on Lake 3, to control the erosion across the littoral zones. Lawn drains were also installed at four locations between homes on the north side of Island Reach Lane where significant erosion had already moved the bank of the lake back almost 4 feet. Once the drains were completed, Palm Beach Aquatics planted muhly grass to fill in the bare areas on the littorals on all three lakes. The water in the lakes looks clean and clear...just the way it's supposed to!

Majestic Isles was selected as one of the six finalists in the 2010 Communities of Excellence Awards in the Disaster Preparedness Category. Although we didn't win the award, it's quite an accomplishment event to have been chosen as one of the finalists from the entire state.

As we start in to 2011, residents can look forward to even more being done to make Majestic Isles a place you can all be proud to call "home." Zimmerman Tree Service will be trimming all of the canopy/hardwood trees – everything except palm trees – this month, and we'll start on redecorating the second floor of the clubhouse. The canopies on the pool, tennis courts and second floor balcony will be replaced, and proposals are being taken to replace the chairs and lounge chairs at the pool.

I look forward to the coming year, in which Board and I will continue to do everything we can to make Majestic Isles the best that it can possibly be.

## Highlights of the December 15, 2010 COBWRA Meeting at Bethesda Hospital

### Sheryl Steckler, PBC Inspector General

*What is an Inspector General?* There are three main areas of activities: audits, contract oversight and investigations. The IG (Inspector General) is not here to punish anyone. "We are here to find problems and recommend corrections," she said. "It is up to management to take the appropriate actions."

- Ms. Steckler believes the Palm Beach County Ethics Code is now the best written anywhere in the country.
- The IG is truly independent. The IG is responsible solely to the people of Palm Beach County.
- An important function of the IG office is to provide training for county employees, vendors and elected officials. The business community is asking a lot of questions and even making suggestions for areas of concerns and investigations.
- The IG is responsible for promoting accountability, efficiency and good government.
- When investigations turn up criminal activity, the findings are turned over to the State Attorney's Office for prosecution.
- Contract Oversight is notified before any county contract is awarded so it can be checked to see if proper procedures were followed and the contract is well written and clear. Is the county getting what the taxpayers are paying for?
- A major goal of the IG office is to find waste and duplication -- saving money for the taxpayers. Miami-Dade County found their IG office saved many times the cost of operating the IG office.
- Results of audits and investigations are posted on the IG web site once complete: [www.pbcgov.org/OIG](http://www.pbcgov.org/OIG)
- Whistleblowers are completely anonymous to prevent retaliation by management. Hotline: 877-283-7068
- Palm Beach County's Office of the Inspector General will be accredited nationally and recertified by the national organization every three years.
- The citizens showed their support for the Inspector General concept by their overwhelming support of extending the IG office to include all 38 municipalities in the last election.
- Presently, the IG covers all of Palm Beach County Government and recently added the Solid Waste Authority. The 38 municipalities are expected to come under by spring 2011. Constitutional officers and the School Board have not yet elected to join.

- The bottom line: Is Palm Beach County getting the best possible government at the best price?

### COBWRA Reports

Canyon Isles, a family community of 500 homes, was approved as the 94<sup>th</sup> member of COBWRA.

### Growth Management, Gerry Morrison, Chair:

- COBWRA Delegates voted to recommend approval of a Development Order Amendment allowing the Walmart on the NW corner of Military Tr. and Hypoluxo to reconfigure the site plan as presented and to recommend approval for re-zoning the property from CG Commercial General to MUPD. The expanded Walmart will be about 125,000 SF and offer groceries plus general merchandise. The building and parking lot will be brought up to the new "Big Box" store code with an enhanced building appearance and redesigned parking lot.
- Delegates were briefed on the plans by Delray Medical Center to open an urgent care center in the approved but un-built 20,000 SF medical office building at Canyon Town Center. The 1<sup>st</sup> floor will be urgent care and a diagnostic lab. Ambulance patients cannot be accepted. Hours planned: 9 am to 9 pm. The 2<sup>nd</sup> floor will be doctors' offices.

The Nominating Committee will report at February COBWRA meeting. Elections will held in March and the new officers installed in April 2011.

## Gardening in the Isles

I wish all Majestic Isles residents a New Year of good luck and good health. In line with this wish, there happens to be a houseplant, the lucky bamboo, that the Chinese believe brings prosperity, fortune and happiness to whoever has one, especially if it has been given as a gift. The lucky bamboo is one of a small group of shrub-like species with slender stalks, and flexible strap-shaped leaves. The lucky bamboo has a well-earned reputation of being nearly indestructible. The tough stems can survive in vases of water under a wide variety of light conditions. Even a poorly maintained lucky bamboo plant will live for a long time before it finally dies.

The vast majority of lucky bamboo plants are shipped from China. The plant can be shaped in a multitude of ways by braiding, twisting and curling the stalks. A three-stalk bundle can be purchased for as little as \$10. The more intricate shapes are more expensive.

In the world of horticulture the lucky bamboo is not labeled as a bamboo at all, but a plant species known as *dracaena sanderiana*. Although you observe that most of these plants are seen grown in water, the plant can be potted in soil. *Be cautious if you have children or pets around, because the leaves are mildly toxic if ingested.*

How does one care for a lucky bamboo? The plant prefers bright filtered sunlight. Avoid direct sunlight, as it will burn the leaves. The plant can tolerate low light, but relocate the plant to a bright spot if the plant begins to stretch outward or the green leaves begin to fade.

Watering this plant is a bit tricky compared to the typical houseplant. It can grow indefinitely in a vase

with at least a couple of inches of pure water and pebbles on the bottom to support the stalks.

I mention pure water because the plant is very sensitive to chlorine and other chemical impurities found in our tap water. Water the plant with distilled water or bottled purified water that has been left out for 24 hours to settle out any chemical impurities. In past articles, I have recommended changing the plant water often. To promote good health in the lucky bamboo, I recommend watering at least once a week.

The lucky bamboo likes household temperatures between 65 and 80 degrees. Do not locate the plant adjacent to air conditioning or heating vents.

You should feed the plant every month or so using a weak balanced soluble fertilizer. A single drop is plenty for most arrangements.

The most common problems related to the lucky bamboo are connected to the water that the plant is immersed in. Chlorinated water will kill the plant over time. Contaminated water that is dirty or infected with bacteria can be fatal to the plant. If the plant develops black roots, these should be cut away. Prevent algae from growing in the water in a clean vase by changing the distilled or bottled water weekly. Leaves that are faded or yellow indicate too much sunlight or too much fertilizer. Remove dead or rotting stalks immediately.

Let's grow the lucky bamboo in Majestic Isles to bring our residents good luck, good health and prosperity in the New Year, 2011.

## INVESTMENT DISCUSSION GROUP

The investment discussion group meeting of the year was held on Monday, Dec.13, 2010 and included the following agenda: Lament, Hope, Euphoria and the

Political Effect.

**Lament:** We discussed the question “How well did you do this year?” You could have been up 10% to 20% in total returns (that includes dividends and capital appreciation). A total return of 5% to 10% would have also been acceptable. Anything less than that possibly means that you may have missed one or more of our meetings this year.

There are ominous signs on the horizon and in many portfolios--signs that interest rates may have bottomed and are starting to rise. The market values of corporate and municipal bonds have begun to fall along with other fixed income without a growth component. Corporates and munis have fallen approximately three to five per cent. Some junk bonds, to date, have held up a little better.

What is the anticipated time frame for interest rates to continue to stay low--which is what the Fed is trying to maintain to stimulate the economy--or to continue to raise rates slowly because of the concern that government policies and the high debt is inflationary? The estimates by some analysts are one year---to which I add, approximately plus or minus one year!!!

**Hope**--Last month we discussed the statistics over the 1922 to 2006 period which indicated that the third and fourth year of a Presidential term are usually favorable for the market, with securities increasing in market value an average of 10% and 7½% respectively. Keep in mind, that to try to make this information work for you, your portfolio ought to include securities that may benefit during a protracted inflationary period. In other words---more “income with growth” and less fixed income (without growth). There is an anomaly here, since you may want to retain fixed income securities as long as you can in order to cope with substantial volatility in market value. In past meetings, we have discussed many securities that meet one or both of these goals.

**Euphoria**--Many securities that pay high dividends (or distributions) had high yields when first mentioned. As the market values have risen since then yields have fallen, some substantially, but their

dividends have essentially remained the same. High current yields of 6% to 9% are now deemed acceptable, yet there are still securities available with dividends such as 12%, 15%, and 20%. These, too, have been discussed before.

**Political Effect**--here we are on less solid ground. Many believe that the key to improving the economy is creating jobs, jobs, and more jobs. That should be the primary concern of Congress and the president. One very prominent argument has been to reduce taxes and to retain the Bush tax cuts. Three thoughts occurred to me:

- If the payroll taxes for the middle class are reduced slightly, will it create enough additional spending to increase jobs, or will it merely permit workers to help pay off their debts?
- If the current Bush tax cuts for the wealthy are maintained at the current level, considering the current jobs status, how will maintaining the current tax rate facilitate a significant increase in jobs?
- Would it not be better for the government to stimulate job growth with aggressive infrastructure programs and to stop the exporting of jobs to foreign countries?

As you can imagine, the discussion that ensued over these questions were vigorous and animated, yet friendly. At this juncture, we can only look forward and pray that the 2011 Congress can come up with answers promoting job growth and an improved economy.

We then discussed an article by Jim McTague in Barron’s entitled “Uneasiness in Muni-Land.” With the market value of municipals generally in a downward trend due to economic stress in many states, he concludes that “The municipal market is no longer the place for conservative investors. It has become nearly as volatile as the stock market”. Some people are not concerned, however, since they will collect the stated principal in twenty or thirty years, though its purchasing power may be much lower than today, without some growth.

The meeting wound up with a review of many securities which have met our concept of high income with moderate growth. Join us in January and have some fun while you participate in broadening your investment horizons. Always remember to do your own research with regard to suitability, risk, etc. in evaluating securities you may be interested in, and discuss them with your investment advisor.

### Our Journal:

#### Saturday, Day 1, 7:45 a.m. call

We reported for duty. After filling out pay vouchers, and signing confidentiality papers, we had a brief orientation with the casting director.

The rules: Don’t approach the stars or ask for autographs. No picture taking on the “set.” Don’t wander from the holding areas. If these rules are broken, you will be asked to leave.

Two scenes are to be shot today, and we are selected for both. We are so excited since both scenes are with Adam, up close and personal.

We spent most of the day waiting and were finally sent to bed at 1:15 a.m. without being filmed.

#### Sunday, Day 2.

This was a day off, so we slept in. Exploring the ship occupied most of the rest of the day. We walked the Promenade, the Boardwalk and Central Park. A description of the ship is a story in itself. Suffice it to say, it’s a fantastic ship and we enjoyed all the amenities.

#### Monday, Day 3. 6:00 a.m. call

One area is for men, one for women. Hats, shoes, scarves and outfits of all sizes, colors and description are on display. Formals, casual and special event costumes line the walls. We estimate the area is 2,800 square feet. Make-up and hair styling are in the adjoining room. We are ten senior citizens being dressed for a shuffleboard scene. Some get fitted with grey wigs. Steve is fine, Enid gets more grey highlights. We wait all day and at 6:00 p.m., we are told to come back tomorrow. We meet for dinner, go to an ice show and by 10:00 p.m. it is bedtime. ## WHAT YOUR SURVIVORS NEED TO KNOW (Part 4)

The personal representative named under your will, usually your spouse or other family member, has the responsibility for preparing an inventory of all assets which were held by the deceased solely in his or her name alone, or in joint names at time of death. For federal tax purposes, the values of the assets are to be shown at **date of death values** (*market value*), and **not at cost**, even if no Federal Estate Tax is due. The date of death value will be the new basis for assets inherited. Unpaid interest on bonds and dividends receivable on stocks must also be included in the inventory.

If you are a named beneficiary who inherits an IRA, life insurance policies or annuities, remember to name your own beneficiaries and contingent beneficiaries. *If the deceased was named as primary beneficiary under your IRAs, life insurance or annuities, it is important to name a new beneficiary or to let the contingent beneficiary succeed to the position of primary beneficiary.* Assets with named beneficiaries are not subject to probate, but are still part of the deceased federal taxable estate. Life insurance policies on the life of the insured, where the insured had no incidents of ownership, are also not part of the taxable estate. *Incidents of ownership* include the right to change beneficiaries, assign the policy to some other person, borrow against the policy or cancel the policy. The inheriting beneficiary will have to decide the question of keeping or surrendering these assets.

Title to an inherited auto should be transferred from the name of the deceased to the name of the person inheriting the auto. Contact the State Department of Motor Vehicles about this. To change title you will need a copy of the death certificate, title and registration, proof of insurance and driver's license. There is a transfer fee involved.

If the deceased was over the age of over 70, required minimum distributions **must be made annually** from an IRA owned by the deceased. In the year of death it is the responsibility of the personal representative to make sure that the distribution for that year has been taken. If it was not taken prior to the death, then the personal representative must take the current required distribution or the balance of distributions for that year. Contact the custodian of the IRA for information regarding the amount of all distributions made

prior to death. Distributions received after death are to be deposited into the estate account. Current year distributions that were not made prior to death cannot be rolled over. *There a penalty levied by the IRS if a current distribution is not made. The IRS penalty is 50% of the difference between what should have been distributed and what actually was distributed during the year plus the income tax due on the distribution.*

To transfer title to real estate that is in the name of the decedent alone, you will need both a certified copy of the death certificate *without the cause of death* and a Personal Representative Deed. Title in joint name will pass automatically by law. The surviving spouse should transfer title on the records of the county in which the property is located. If this is not done, the records will not show clear title to the property. Absence of clear title can cause problems transferring the property after the death of the surviving spouse or upon the sale of the property.

At present, a surviving spouse has the *option to elect* (that is, to claim) **30%** of the deceased spouse's assets, including those in the probate estate, the decedent's revocable trust, jointly owned property, beneficial interest in the cash value of life insurance immediately preceding death, and many other assets. This is called the **"elective share."** The claim for the elective share must be filed the earlier of six months after date of service on the surviving spouse of copy of notice of administration, or two years after death.

Review medical and long term insurance policies, auto insurance and any other insurance that may have expired with the death of your spouse. Request refunds of any unexpired insurance premiums.

Notify credit card companies and banks that issued the cards, of the death of your spouse and request that the cards be cancelled. Request that a card be issued in your name if you do not have one.

**Take time to consider your situation and don't rush into anything you might later regret.**

In Athens, we climbed slippery marble steps with no handrails to the top of the Acropolis. I'd never have made it without the help of friendly passersby. We saw the Pantheon (under renovation) and enjoyed the colorful synchronized changing of the guard at the Tomb of the Unknown Soldier. ## A YEN FOR YOGA

When was the last time you felt pain-free, free from twinges in your back or your knees? Perhaps the twinges come from gardening or climbing stairs, or simply stepping up or down to get to your car - but

Instead of reaching for medication, many doctors suggest exercise to boost muscle flexibility. This means using proper body movements to prevent and to correct problems that arise from poor posture. A good starting point is to st-r-e-tch. As we age, we get into the habit of using our bodies in ways that cause muscles to become tense and tight. This tends to limit our body movements. And tight, short muscles are also more vulnerable to injury. So st-r-e-tch, particularly after a warm bath or shower.

But wait! Where does Yoga fit into the scheme of things? Yoga actually began 5000 years ago in India, as a method to become one with the universe. It began as a philosophical and spiritual discipline, but has evolved to create training for the body and the mind. "Yoga" means union – and relates to the connection between mind, body and spirit.

A yen for yoga has inspired many new yoga entrepreneurs and students in South Florida. According to the newspapers, at least 12 yoga studios have opened from Broward to South Palm Beach, in addition to gyms, the JCC and numerous yoga videos. Obviously, there are many stressed out Floridians who seek yoga instruction.

Yoga combines stretching with meditation and controlled breathing. This can relax tense, painful muscles. Research indicates that yoga can lower blood pressure, so you also get benefits for the health of your heart.

There are many beginner, intermediate and advanced technique. A simple example is the Alexander Techniques. This technique re-educates the body in the art of correct alignment from the head down so that muscles aren't under constant stress and strain from compensating for poor posture. It also helps to relieve back pain. Do you remember when your mother told you to walk with a book on your head? She was on to

something! Your posture is a technique you can practice at home. All it requires is for you to picture an imaginary string running through your body and out the top of your head. Concentrate and pull yourself straight up with it. Voila! You stand upright in a proper stance. Also, avoid slouching when you sit, and stand tall when you walk.

There are many yoga workouts that are best conducted with an experienced instructor. They have peculiar names, the Hablia, the Bridge, the Cobra, the Mountain, the Triangle, the Warrior 1 and 2, a downward facing Dog and Sage, to name some. These are all fairly simple, low impact exercises to help you shape up. They were created to help strengthen shoulders, the lower back, and legs, and to stimulate the circulatory, digestive, and lymphatic systems. Some yoga variations stimulate the thyroid and parathyroid, as well as reduce fatigue. Other variations of yoga strengthen thighs, knees, ankles, kidneys, hamstrings and even help with insomnia. It is always advisable to see a physician before undertaking any exercise class. However, yoga instruction is relaxing and on the increase, and the benefits derived from following instructions are multiple.

In addition, I recently read in the newspaper about "laughter yoga" which is offered to Alzheimer patients and their caregivers. A patient said "It gives me happiness inside of me." Laughter yoga is not a cure, but it brings more energy into the body and stimulated stability and balance. The director Ericka Ruiz claims that laughing for no reason is just as healthy as laughing after a joke. The basic idea is clap, breathe and laugh. It seems to indicate that laughter is the best medicine!

Another activity also caught my attention. It was entitled, "Improve your vision by way of eye yoga." The technique here is to stretch the eye muscle to increase flexibility, relaxation and stamina.

The various low-impact techniques required of yoga have made it increasingly popular as an exercise. The only equipment you may need is a rubber mat to prevent slipping. Also blocks and straps are optional.

If you've been telling yourself it's time to shape up for the New Year, I say "Go for it!" A new you will emerge if you continue your workouts. Join the multitudes with a yen for yoga.



## THE BIG BAND ERA

*Editor's note: Josh's death on Dec. 24 is a big loss to Majestic Isles. In his memory, we are reprinting this column, which appeared in the 2004 summer issue.*

In 1941, the recording industry paid out millions of dollars in royalties to working musicians. However, there were no royalties paid for the use of recordings on radio programs and in jukeboxes. The president of the American Federation of Musicians, James Caesar Petrillo, decided that this would not do. His argument was that if the record companies couldn't devise some system whereby musicians were paid for the use of recordings on radio and in the jukeboxes, then he wouldn't let them record at all. Almost every big band leader disagreed violently with Petrillo's actions, but James Caesar stuck to his battle plan. He banned all recordings from union musicians as of August 1, 1942. Since all non-vocal recording artists were members of the union (including members of all the major symphony orchestras), the recording industry ground to a stop. During the few months preceding the ban, the record companies had just about every band in the studios day and night trying to build up a stockpile of records – and these were released little by little during the coming months.

Singers were not required to be members of the musician's union, so they were able to record, and record they did, accompanied by chorale groups. Interestingly, the first records made as singles by Dick Haymes, Perry Como and Frank Sinatra were done this way. Sinatra did make some recordings under his name a few months prior, but at the time he was still a member of the Tommy Dorsey orchestra. However, the biggest selling record during the record ban, and one of the biggest selling records of all time was a recording of "Peg O'My Heart" done by a group known as the Harmonicats. You see, the harmonica was not recognized as a musical instrument by the union.

For more than a year, no major company made any records with musicians. Finally in September 1943, Decca signed a new contract with the union, and a month later, Capitol followed suit. It wasn't until a year later that Victor and Columbia signed.

Actually many recordings were made by the big bands during the course of the ban. They were made solely for the uses of our servicemen, and released as

"V-Discs." They were not sold in stores and were never played on radio stations and in jukeboxes. Well over a thousand of these were made, strictly as a morale booster for members of our armed forces. Many years later, just about every V-Disc recorded was finally made available to the general public via reissues on LP's, cassette tapes and CD's. In listening to these, it is interesting to compare the V-Disc version with the commercially recorded version of the same material.

During the war many musicians and a number of leaders either enlisted or were drafted in the Armed Services. The leaders included Dean Hudson, Artie Shaw, Orrin Tucker, Eddy Duchin, Claude Thornhill, Clyde McCoy, Ten Weems, Bob Crosby, Larry Clinton, Ray McKinley (who passed away in 2004) Bobby Byrne, Sam Donahue and Glenn Miller. The bands that still functioned pitched in to the war effort by playing in service camps and touring with USO units to play for the servicemen overseas. Though some of the top bands, like Tommy Dorsey, Les Brown and Harry James continued to do well, certain problems did arise, some of which were eventually to contribute to the decline of the big bands. Gas shortages made traveling not only difficult for the bands but also almost impossible for fans who wanted to go places outside the city limits. Top spots like the Glen Island Casino (New Rochelle, NY) and Frank Dailey's Meadowbrook (Cedar Grove, NJ) were forced to close. Then there was the 20% amusement tax, a midnight curfew, and as cited earlier, the recording ban.

By the war's end, the world of popular music had become primarily a singer's world, not only on records, but also on radio shows that once featured the top bands. Frank Sinatra, Perry Como, Dick Haymes, Andy Russell, Dinah Shore, Jo Stafford, Peggy Lee and others had replaced the bands as top musical attractions.

Some of the big bands continued, and a few of the top ones still thrived. However, it was becoming more and more difficult for the big bands to continue. Finally, in late 1946, the big band bubble burst with a bang. Inside of a few weeks, eight of the top bands broke up – Benny Goodman, Woody Herman, Tommy Dorsey, Les Brown, Jack Teagarden, Benny Carter and Ina Ray Hutton.



## GOURMET CLUB

The sounds of "Fiddler on the Roof" put our Gourmet Club in the right mood for their evening of Jewish cooking at the home of Marvin and Joan Sorkin. We were determined not to make the usual cooking we grew up with. We ventured out into the world of Jewish cuisine around the world.

### FISH IN HAZELNUT CRUST

¾ cup shelled hazelnuts	2 eggs beaten
¼ cup dry bread crumbs	1 cup flour
½ tsp. ground coriander	1 tsp. cayenne pepper
2 tsp. ground cumin	Salt to taste
1 ¼ lb. red snapper or tilapia sliced into 8 equal size pieces	
1 Tbsp. butter	

- Place nuts in dry skillet and cook about 15 minutes until toasted. Do not allow to burn.
- Wrap nuts in clean cloth and rub to remove skins. Chop fairly fine and mix with breadcrumbs, coriander and cumin and spread mixture on a plate.
- Place eggs in bowl. Combine flour, pepper and salt and spread in another plate
- Dip fish into flour mixture and then in eggs, allowing excess to run off. Press fish into crumbs.
- Place fish on a plate and refrigerate until ready to cook, up to ½ hour.
- Heat butter in nonstick skillet. Place fish in skillet and cook over med-high heat until pieces are lightly browned – turning once – 2-3 minutes each side.
- Serve at once.


Bonnie Haberstick reminded the group that if you to be included in the M.I. directory, you must sign the permission sheet on the lobby desk.
